Ann Dare, late of Calvert County Maryland, appears on the definitive list as a claimant for Two negroes lost during the late war – viz – William L Dick: - Mrs Dare has died since her claim was filed, & letters of Administration have been granted, by the Orphans Court of Calvert County, to Nathaniel Dare – of wh: fact a certificate of the Register of the Court, is filed, with a power from the administrator to the subscriber to act as his agent – The Depositions of John Dare & Jacob Breden disinterested witnesses prove the property of Mrs. Dare in the Negroes William L Dick – that they absconded from her service in the month of August 1814, & were taken away by the British Enemy –

The administrator hath filed the depositions of Abigail Jany and Henry Mitchell to prove further the property of Mrs Dare in [illegible] negroes, that they absconded to the British, during the late war - & that negro William was called & known by the name of William Mitchel, & negro Dick, by the name of Dick or Richard Corn: or Cornelius - The deposition of John Allen filed in the case of Juliet Rawlings, a Mary land claimant, residing in Calvert County – proves that a negro called

land claimant, residing in Calvert County – proves that a negro called Mary Mitchel, the property of Juliet Rawlings, was the wife of William Mitchel & that they absconded during the late war – (a copy of the deposition is filed in this case) the Evidence in Juliet Rawlings case is respectfully referred to –

The claimant is without direct proof, as to the time when these negroes were taken from the United States – except so far as such proof is furnish by the British lists -

at page 276 of this Book of printed lists, a negro named "William Mitchel" appears to have been on board the Devastation on the 30 March 1815 then lying at Cumberland Island -

at page 91 of the Halifax list of negroes recieved [sic] into the province of Nova Scotia from the U States of America" after the 27 April 1815 – is found a

Negro called William Mitchel in company with his wife – this negro is said there to be about 64 years of age – the claimants negro William was supposed to be about 55 years old when he went away – there is no certainty in regard to the age of a negro – it rarely happens any memorand [sic] is made of it, & the exposure they are subjected to generally makes them appear older than they actually areit is highty [sic] probable that the negro on the Halifax list is the same who absconded from Mrs Dare – the correspondance [sic] in point of age, & the fact of his wife, being with him, make it highly reasonable to presume them the same -

There is another circumstance that adds to the probability, and it is this – There is no negro on either of the lists, named Dick Corn or Cornelius, the name by wh: Mrs Dare, others lost negro was generally known – but on the Halifax list & immediately preceed ing the name of William Mitchel, there is Richard Mitchel It is not unreasonable to presume that this is the negro of Mrs Dare – the proof is that they left their mistress together, the coincidence of their Christian names, & the probability that Richard may have been entered on the Book of the vessel in wh" they took refuge by the same name as William. affords a reasonable expectation that the Board will award to the claimant the value of both the negroes
