The claim of James I. Bourne of Calvert County
Maryland, for one slave. Jim – alias James Handy
is respectfully submitted.
The depositions included in paper marked A
shew the logs of Jim & his absconding to the British forces
in the Chesapeake.

The depositions included in paper marked B – show prove that James Handy, the slave of James I Bourne had Dolly Handy, the slave of John M Gray of Calvert County for a wife by whom he had a child called Sophy Handy -The object of these depositions being taken by Mr. Bourne in support of his claim appears to be to prove that John M. Gray. lost but two slaves. 2 that the one named by Mr. Bayley on the Tangier list, as the slave of John M. Gray by the name of James Handy must have been his Mr. Bourne slave. But in this Mr. Bourne is clearly mistaken as by reference to page 111 of the printed documents – to the description list of black & colored people on Tangier Island. Taken by our commissioner Thomas M Bayley -James Handy is placed under the head of childrens names immediately below the name of Sophy Handy, the daughter of Dolly Handy. For Gray's slave at page 33 of the printed documents, furnished by the British government containing a list of supernumeraries on board the ship Madagascar – James Handy is placed

by the British officers among the refugee children on board that ship – These documents therefore prove that this James Handy could not be the husband of Dolly Handy.

The papers filed shew that Mr. Bourne negro man James Handy was of the age of 23 years & the commissioners by refering [sic] to the papers in support of the claim of John M. Gray will perceive that Dolly Handy was about the age of 19 years & her child Sophy about 4 years. It is quite probable that James Handy mentioned on the Tangier list was the child of Dolly & born after she absconded from the service of her master & joined the British forces.

The name of Mr. James I Bourne negro man James Handy is found at page 18 of the printed documents on the list of colonial marines – This man must be the slave of Mr Bourne, & for whom he claims indemnity.
