The depositions filed in the office of the Secretary of State in the year 1821 – show that Moses had been seen armed acting as a soldier with the British troops – at the time B. H. Mackall's house was burnt in Calvert County was burnt by them – the deposition of Dorcas Spalding now filed proves that she was an eye witness to the same facts - & which deposition the commissioners [illegible] refers.

I was under the impression from a letter which I received from Mr Bond that he expected to be able to prove that the sir – [sic] name of Moses – was Grace - I therefore wished the commissioners not to decide the case of Artemisia Skinner until [illegible word crossed out] the proof in J T Bond's case was received –

Skinner that I should state that the deposition filed in her case revising the sirname [sic] of her man Moses – to be Grove was in my posesion [sic] for some weeks before I filed it & from information which I received at the time I believe to be entitled to credit – that the deposition was taken without any knowledge on the part of the claimant that there was any Negro named Moses Grove on the list of colonial marines – no person in the family of A. Skinner having ever seen the printed documents -
